CONTRACT AGREEMENT

Project Title: "SUPPLY, DELIVERY AND INSTALLATION OF SOLAR POWERED IRRIGATION SYSTEM IN BENGUET AND MOUNTAIN PROVINCE with an ABC OF P2,100,000.00"

THIS AGREEMENT is made on APR 23 2021, between Department of Agriculture-Regional Field Office-Cordillera Administrative Region, with office address located at BPI Compound, Guisad, Baguio City, Philippines, hereinafter called "the Entity" of the one part and, Darlene General Merchandising, of Silao St, Purok 2, Bulanao, Tabuk City, Kalinga, hereinafter called "the Contractor" of the other part;

 - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. 
