

CONTRACT AGREEMENT

Project Title: "Supply and Delivery of Post-harvest Machineries under IB No. 2021-03"

THIS AGREEMENT is made on _____, between Department of Agriculture, Regional Field Office, Cordillera Administrative Region, with office address located at BPI Compound, Guisad, Baguio City, Philippines, hereinafter called "the Entity" of the one part and EQUITY MACHINERIES, INC. of Cauayan City, Isabela hereinafter called "the Supplier" of the other part;


