THIS AGREEMENT is made on MAR 26, 2021, between Department of Agriculture-Regional Field Office-Cordillera Administrative Region, with office address located at BPI Compound, Guisad, Baguio City, Philippines, hereinafter called "the Entity" of the one part and, DMYA Construire Construction of Purok 1, Bulanao, Tabuk City, Kalinga, hereinafter called "the Contractor" of the other part;

 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
